Topic	Discussion
Welcome	Rui Magalhães opens the meeting and does the roll call. Rui Magalhães explains the main points for the meeting:
Bardonecchia	Waxing tents are ready. We also cleared out a 100m² warehouse to fill it with waxing tables. You can use your own table. This is a heated place, and you will find access at the entrance of the Olympic Village in Bardonecchia, on the right side at -1 floor.  The inside storage space is open from 9 to 21, we have to keep it under surveillance so we can't keep it open 24/7. Let us know if those opening hours work for you and are enough.
	Late snack in Bardonecchia is being provided, starting form yesterday. Please let us know if the level is up to our standards.
Non-smoking event	We would like to remind you that this is a non-smoking event. Today someone smoked in a locker room in Palatazzoli and that is completely not allowed. At any events, indoor or not, please do not smoke. If you do so, please leave the area.
Closing Ceremony	We sent you an email on the Closing Ceremony: we need you to provide data. Everybody should send their participation numbers and please do it by hotel. Failing to communicate correct numbers will greatly harm the organisation, because we need to provide buses and we need the exact numbers.
Departures	You'll be receiving schedules for the next day during the afternoon. If you have changes, please send them to Arrival and Departures via email (and@wugtorino2025.com; arrivalanddeparture@wugtorino2025.com). Enzo Calabrò will explain how the transportation works. If you have particular logistic needs (such as big luggage), please inform us in advance.
IHOM transfers	The final four will be revealed in the next days. In the morning of the 20 <sup>th</sup> January, the semi-finalists will be moved to hotel B&B Borgaro and the check-out will be at 10 am. In case you need to move luggage, the situation may be different so at a later stage tomorrow we will tell you how we are going to proceed and send further information on how to store luggage.

Closing Ceremony

Q (CRO): Do we have some kind of march or will it be free standing? A (Rui Magalhães): It will be free standing. There won't be flagbearers and no particular choreography.

Jiho Kim: We will have a HoD Meeting on the morning before the Ceremony, when we will give the specifics.

Food at Palatazzoli

Q (GBR): I really need your help with the curling venue. We have asked for food. Our team leader and medical staff are there for more than 10 hours a day and they've been told that they can't eat at the venue. Officials don't have time to leave and buy food. Please help us find a solution.

A (Rui Magalhães): After the meeting give us the numbers so that we know how many meals we need to provide.

Transportation to Palatazzoli Q (GBR): There are inconsistencies in the line for Palatazzoli. We need a timetable, and we need people to stick to it.

> A (Enzo Calabrò): We adjusted the timetable. Today the issue was that the pick-up foreseen time was at 11 but the departure was earlier. I'm sorry, it was a problem of miscommunication. We will make sure that the new schedule will be respected.

IHOM accommodation

Q (USA): USA and SVK would prefer not to change hotel if they are making it to the semi-finals.

A (Rui Magalhães): The Technical Committee Chair has decided to move the semi-finalists to hotels closer to the venue and this is non-negotiable.

Transportation for the Gala Reception

Q (CHI): Is there going to be transport for HoD for the Gala Reception on Sunday?

A (Enzo Calabrò): Transportation plan has been agreed with Protocol. We established that only FISU Family will be transported to Venaria Reale after the Exhibition Gala at PalaVela. HoDs will have to make their own way to the Gala.

Meal times for athletes in SES/PRA

Q (FRA): Would it be possible to adapt the meal times for CCS, SMO and BTH to the training and competition schedules?

Too often the teams are unable to eat or have very tight schedules.

A (Rui Magalhães): We have adapted them. I was there yesterday and I got no complaints for BTH. As for CCS and SMO in Uappala, we agreed we would open at 6am. Let me know if there are complaints for today.

CCS team departure

Q (JPN): We have not received detailed info on how to manage skis and sport equipment yet. Can we ask their departure bus to leave their hotel and then stop at Pragelato CCS venue wax cabins to pick up and load their skis, before heading to Torino airport? This way, they can leave skis and equipment at the venue on the 23rd. This will allow them to have time to get prepared for the Closing Ceremony.

A (Rui Magalhães): The process of picking up the skis at the venue will be organised with the Logistics team. Transportation will be according to the schedule.

IHOM accommodation

Q (CAN): Are IHO teams that don't make it to the semi-finals staying in the

same hotel or going somewhere else?

A (Rui Magalhães): Yes, they're going to stay in the same hotel.

**Ticketing** 

Q (CAN): We are having issues with double-verification requests. We do not get the code through messages so we cannot log in and buy tickets online. Are there places where to buy them, and how many are left? A (Rui Magalhães): I'll have to contact ticketing for that.

Transport to the airport

Q (AUS): Is it possible to arrange for transfers to the airport for officials who have to return delegation cars to the Lingotto car park the day they depart?

A (Enzo Calabrò): First of all, you all need to return cars at Lingotto. We are not arranging individual transportation from Lingotto to the airport. I remind you that there is also public transportation available, very accessible to the train station. If you have difficulties with times, you can mention it to our Arrival and Departures team.

Accommodation after Closing Ceremony

Q (CAN): We have a lot of people leaving at 6am the day after the Ceremony. Is there a way to relocate them in Torino, so that they don't go back to Bardonecchia and then back to the airport in the same night? A (Rui Magalhães): I don't think it will be possible to relocate them in Torino but let me get back to that.

Notices for Olimpia

Rui Magalhães: For the Closing Ceremony we ask you to specify your meal choices, same as you did for the Opening Ceremony (regular, vegetarian, gluten-free and lactose-free).

We also ask you to confirm your presence at the Gala Reception at Reggia di Venaria on Sunday. Invitations are limited to one person per delegation.
